In exercise of the powers conferred by section 22 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), the Government of Kerala, being satisfied that it is necessary in the public interest so to do, hereby make the following amendment to the Notification issued under G.O. (MS)No.16/96/Trans dated 31st March, 1998 and published as S.R.O. No.301/98 in the Kerala Gazette Extraordinary No.546 dated 31st March, 1998, namely:-



AMENDMENT

In the said notification, for the words "Seven Lakhs", the words " Fifteen Lakh" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In exercise of the powers conferred by section 22 of Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), the Government as per notification issued under G.O(MS) No.16/96/Trans dated 31st March, 1998 and published as S.R.O.No. 301/98 in the Kerala Gazette Extraordinary No. 546 dated 31st March, 1998, the three wheelers, invalid carriages, motor cycles and motor cars which are owned by the differently abled persons for their own use were exempted from payment of tax payable under the said Act.

The Government as per notification issued under G.O (P) No.29/16/Trans dated 18th March, 2016 and published as S.R.O.No. 296/2016 in the Kerala Gazette Extraordinary No. 708 dated 29th March, 2016, the said notification was amended for limiting the tax exemption for the said category of vehicles having a purchase value up to rupees five lakhs.

The Government as per notification issued under G.O (P) No.1/2018/Trans. dated 12th January, 2018 and published as S.R.O.No. 32/2018 in the Kerala Gazette Extraordinary No. 105 dated 19th January, 2018 such purchase value was increased from rupees five lakhs to rupees seven lakhs.



In para 315 of the Revised Budget Speech for the financial year 2026-27, it was announced to enhance the motor vehicle tax concession for differently abled persons by increasing the eligible vehicle value limit from the existing rupees seven lakh to rupees fifteen lakh. In order to give effect to the said announcement, the Government have decided to amend the notification issued under G.O. (MS)No.16/96/Trans dated 31st March, 1998 and published as S.R.O. No.301/98 in the Kerala Gazette Extraordinary No.546 dated 31st March, 1998, accordingly.

The notification is intended to achieve the above object.
